**(Note: -Please note cheques are not allowed)**



5.	Display of final list of nominations (after withdrawals, if any) (Within one day of last date of withdrawal)	22/01/2022
6.	Date of Election (if the nominations exceed more than the number of vacancies) (As per Schedule)	31/01/2022
7.	Declaration of Result (As per Schedule)	01/02/2022
